E ENVIRONMENTAL

S SOCIAL

Looks at how a company manages relationships with employees, suppliers, customers, and communities, focusing on labor practices, diversity, and community engagement.

G GOVERNANCE

Evaluates a company's leadership, executive pay, audits, and shareholder rights, ensuring transparency and ethical management.



SHIPPING PERSPECTIVE

- E ENVIRONMENTAL**
Emissions (IMO, EU, locally), Hazardous waste, Dumping, New fuels, Protection of marine environment
- S SOCIAL**
Rights and protection of the seafarers and their mental health, Immigration v. Search and Rescue, Harassment, “Social dumping”, Right to protest

Present legislation and enforcement, New initiatives, Whistle blowing
